## 1. Terms of Reference (ToR)

### 1.1 Background

Araku is a valley in the Eastern Ghats located at a distance of 110 kms towards north of Visakhapatnam, Andhra Pradesh, amidst idyll settings. The valley is blessed with serene forests, marvellous landscapes, fascinating hill stations, mesmerizing waterfalls and mysterious caves, inhabited by fascinating indigenous tribes. Situated close to Orissa border, this hill station is popular for its relatively intact exquisiteness and the verdant green environs. The very journey to Araku Valley, with thick forests on either side itself, offers cool and picturesque spots en route that fill the soul with nature's bounty. A journey by train is exhilarating, as the train wends its way through imposing hills, passes through 46 tunnels and forests, and touches Asia's highest railhead at Shimliguda before reaching Araku.

The Unique Selling Point (USP) of the proposed circuit is a drive through some of the scenic and vibrant tourist attractions. The highlights of the proposed circuit are:

- Embark on a grand journey through eco friendly attractions namely Ananthagiri Hills, Borra Caves, Pathabaluguda (Sunkarameta), Tribal Museum, Tribal Hamlets such as Chompi & Kondiba Villages, Kollaput, Chaparai Waterfalls, Paderu, Dallapalli, Lambasingi etc.
- Drive through the most pristine settings ranging from serene countryside to mesmerizing waterfalls and amazing natural caves.
- Stay in guesthouses and cottages which follow the norm of locally beneficial tourism.
- Experience an age-old folk dance (Dhimsa Dance) of the aborigines.
- Shop for locally made crafts, artifacts, ornaments and forest produces.
- Taste the food of the tribes, which mainly use local herbs, meat and vegetables indigenous to the region.

However, there is a boundless need to develop these tourism destinations duly upgrading the existing Tourism facilities to show case hidden natural attractions to the tourists, both domestic and international.

1.2 During the recent years Araku Valley tourist footfall is increasing especially during summer/winter holidays and weekends. Tourists often visit Borra Caves, Padmapuram Garden and Tribal Museum . Hence, there is a need to improve the tourist amenities and facilities in coordination with ITDA to improve tourist's facilities for comfort engagement with the following .

- 1. Providing Temporary Tented Accommodations
- 2. Establishing the Adventure Sports
- 3. Conducting Cultural Activities
- 4. Providing Food Courts



### 1.3 Tourism in Andhra Pradesh

Government of Andhra Pradesh (GoAP) vision is to be amongst the top 3 States in India by 2022, the top State in India by 2029, and be the most preferred global destination by 2050. The government is taking steps to provide an environment conducive to economic and social growth. These steps include formulation of investment friendly policies, creating world-class infrastructure, improving governance and taking necessary steps to attract investments into the State.
